

Nebraska Taxpayers for Freedom has released its annual report on the conservative voting of members of the Nebraska Unicameral during the **2021** session. NTF rates senators based on their fiscal responsibility, intervention into the private lives of Nebraska citizens, and positions on legislation dealing with law and order.

NTF rates state senators based on a curved point scale. NTF tracked 98 bills and resolutions in the 2021 session. Starting at a base of zero, senators received 1.03 points for each good vote.

**In first place was State Senator Rob Clements (District 2). Clements also was our 1<sup>st</sup> place state senator in 2019 and 2020. Placing second was State Senator Steve Erdman (District 47). Placing lowest was State Senator Megan Hunt (District 8).**

Numbers assigned below are not percentages. They are points on a curved scale. The higher the number, the more conservative the voting record.
