NEBRASKA TAXPAYERS FOR FREEDOM ISSUE PAPER: NO TAX \$\$ TO ILLEGAL ALIENS.

BACKGROUND. Leftist American lawyers are reaping thousands in fees by representing illegal aliens who sue the federal government and individual states over supposed harassment and illegal conduct during detention. Unfortunately, the Biden Regime encourages these baseless lawsuits by blaming the Trump Administration and state governments for supposedly violating the constitutional rights of these illegals, though they are not legal citizens. RELIEF BILL. Conservative Rep. Nicole Malliotakis (N.Y.) introduced **HR 6122**, to prohibit payment of legal settlements to illegal aliens. NE Cong. Adrian Smith co-sponsors this bill, which currently is in the House Judiciary Committee, awaiting a vote to advance it to the full House for debate. Specifically, the bill prohibits federal funds, including from the federal Judgement Fund, from paying for a legal settlement to an illegal alien whose lawsuit bases only on his lawful

detention as part of a family unit at a point of entry along our southern border. The Biden Regime plans to settle over 900 lawsuits filed against the federal government by admitting that thousands of illegals suffered trauma from detention and family separations after crossing the border during the time of Trump Administration strong and efficient immigration enforcement policies. The total payout to illegals and their leftwing attorneys could reach over \$1 billion tax dollars. Illegal aliens could reap \$450,000 each. While Nebraska families are struggling financially to keep pace with the Biden Regime uncontrolled inflation, illegal aliens could live very comfortably. These payments would worsen our border crisis by offering incentives for thousands more illegals coming worldwide to cross over and cash in on Biden Regime largesse.
