

## DOUGLAS COUNTY COMMISSIONER VOTING RECORDS:

**2-4-20.** To support **LB 1095**, to allow Douglas County to establish a juvenile justice program, though state probation currently administers such programs. The bill would permit the county to begin services for juveniles regarding assessment, supervision, placement, and reentry into society. Liberal Douglas Co. Commissioner Chris Rodgers spoke in support. The Legislature purposely unified such probation services in 1985. **YES, against taxpayers:** Boyle, Cavanaugh, Duda, Kraft, Morgan, Rodgers.

**2-11-20.** To approve the city-county building commission selling \$200 million in bonds to build an extravagant new juvenile detention facility downtown. **YES, against taxpayers:** Boyle, Cavanaugh, Duda, Kraft, Morgan, Rodgers.

**2-25-20.** To support **LB 627**, to prohibit job discrimination by government agencies and subdivisions, unions, employers or employment agencies against sexual perverts, another burden on businesses. This bill gives state government the use of coercion and punishment to force conduct that conflicts with employer beliefs.
