## NTF issue paper: president94.doc. 9-23. **NEBRASKA TAXPAYERS FOR FREEDOM ISSUE PAPER: BIDEN REGIME WANTS TO GIVE JOBS TO ILLEGAL ALIENS.**

**BACKGROUND**. The labor force participation rate for Americans continues to decline, as more citizens decide that they can subsist very well on generous welfare payments and not have to enter the work force. The result is that many employers have become desperate for employees, offering higher wages and bonuses. Some regrettably hire individuals who they otherwise would not want working in their establishments. Liberals and chambers of commerce corporate interests that wish to maintain low wages to the rescue! Both strongly urge the Biden Regime to allow illegal aliens the privilege of taking American jobs without undergoing security or health screenings. Meanwhile, millions of illegals already are holding U.S. jobs no longer available to job-seeking citizens.

THE BIDEN REGIME PLAN. The Biden Dept. of Homeland Security (DHS) has begun a nationwide workforce



**IE PLAN.** The Biden Dept. of Homeland Security (DHS) has begun a nationwide workforce initiative that will funnel into American jobs 3 million illegal aliens already paroled into our interior with no vetting and those with pending asylum claims. The Immigration Service sent hundreds of thousands of emails and text notifications in English, Spanish, and Haitian Creole to leftwing nonprofit groups who aid illegals and to migrant groups to explain the process and provide illegals with codes for instant access to employment authorization documents. DHS is connecting mostly with illegal aliens from Cuba, Nicaragua, Guatemala, Haiti, and Venezuela. DHS will continue these efforts with state and local officials. Eligible illegals can start an account and fill out a simple form to mail in for approval.<sup>1</sup>

**THE RESULT.** 44 million Americans remain jobless. Researchers warn that a flooded labor market, a result of mass immigration, will decrease job opportunities and wages for citizens, especially blue collar workers. A study by the Center for Immigration Studies (CIS) found that for every 1% increase in the immigrant percentage of an American worker's occupation, citizen weekly wages drop by 0.5%. This means that average native-born Americans suffer weekly wage reduction by potentially 9%, because over 18% of the workforce is foreign-born.<sup>2</sup> Growth in the foreign-born labor force has accelerated by 50,000-160,000 per month this year, lifted by a surging foreign-born labor force participation rate, states Goldman Sachs. From 1960 to 2023, for instance, the number of native-born American men 16 to 64 years old not in the labor market increased by 13.7 million. Over that same period, the number of foreign-born workers 16 to 64 years old in the labor market increased by 13.7 million. The share of U.S.-born men 20 to 64 without a bachelor's degree shows a decline in labor force participation from 93% in 1960 to 87% in 1980, 84.1% in 2000, and 77.3% in April, 2023, CIS researchers noted. In April, 2023, 85.8% of foreign-born, working-class men were in the workforce, almost 10% more than native-born American working-class men.<sup>3</sup>

**TAKE ACTION NOW.** Help guarantee jobs for American citizens. Help stop the flood of illegal aliens into our workforce, a travesty that depresses real wages and benefits and standards of living and relegates lawful citizens, especially Whites, to the rear in employment opportunities because of preferential solicitation of illegals and existing reverse discrimination against Whites. Using the above information, lobby your congressman and 2 senators to kill this Biden Regime danger to our employment force and economy. Tell them to tighten the welfare rolls, so that able-bodied adults will have to seek employment and fill job openings.
