

**NEBRASKA TAXPAYERS FOR FREEDOM ISSUE PAPER:**  
**STOP POSSIBLE PALESTINIAN TERRORISTS FROM ENTERING U.S.**

**BACKGROUND.** Because of the ongoing terrorist war against Israel, many of the terrorist groups involved have made dire threats against the U.S. and our population here and overseas, because Israel is our ally and deserving of our continued support. Therefore, it is crucial for our government to prevent from entering the U.S. possible terrorists from countries and areas known hostile to the U.S., particularly the Palestinian areas. Two conservative congressmen have introduced a bill to protect U.S. citizens from such possible terrorism.



**THE BILL.** Conservative Reps. Tom Tiffany (Wisc.) and Andrew Ogles (Tenn.) introduced **HR 5959**, to make ineligible for visas or parole aliens holding passports issued by the Palestinian Authority. The Palestinian Authority is the governing body of the Israel-occupied West Bank since 1994. This legislation would ban the Biden Regime from allowing entrance of Palestinians wishing to settle in American communities. The bill would prevent the Dept. of Homeland Security (DHS) from funneling Palestinians here through its parole program. Following the shameful Biden Regime withdrawal from Afghanistan, Biden used this parole pipeline to resettle almost 100,000 Afghans in American communities, many never interviewed by immigration authorities and who later found linked to terrorist groups. In FY 2022, DHS issued green cards to about 63,000 immigrants to permanently settle here, coming from countries included in a national travel ban list because of links to terrorism. One year after this catastrophic withdrawal from Afghanistan, the DHS Security Inspector-General issued a damning report, admitting that DHS did not have “critical data to properly screen, vet and inspect” those refugees who came to the U.S. “Following the horrific attack by Iranian-backed Hamas terrorists on innocent Israeli civilians, the last thing America ought to do is trust identity documents issued by the radicals that oversee these territories,” Tiffany said, “We need to put our security at home first and that starts by closing the door to bad actors who might be seeking to enter our country.” “We can’t let President Biden abuse our parole and visa rules to bring unvetted Palestinians into American communities the way he did with thousands of unvetted Afghans,” he continued. “At a time when the threat of terrorism is not only grotesquely on display but being encouraged and justified, it is critical that we do our best to ensure the security of our nation,” Rep. Ogles said.

**TAKE ACTION NOW.** Because of the open borders policy of the Biden Regime, which allows potential terrorists easy ways to cross our borders and gain access to our communities, and because Palestinians already residing here, particularly students, angrily have denounced U.S. foreign policy, it is imperative to use all means to keep potential terrorists and their sympathizers out of our country.
