FAULTY FINANCES. The LC credit card balance showed -\$2,993 on April 1, the negative balance increasing to \$3,241 by April 30. The LC spent tax \$\$ on a kiddie tour to the radical Malcolm X Memorial. It wasted over \$26,000 on a public relations firm for increased website accessibility, a digital newsletter, and 6 published stories called continued positive media coverage. The firm also boasted a whopping 54 new media followers for the LC. Money wasted on GED and English as a Second Language instruction for student parents. Several salaries raised by 108%, with a 59% hike in fringe benefits. A 12% wage increase for select teachers. A new partnership with the radical Redress Movement.
