
## NEBRASKA LIBRARY ASSOCIATION WORKS AGAINST TAXPAYERS.

**BACKGROUND.** The Nebraska Library Association (NLA) is a state chapter of the radical Left American Library Association. Its funding derives from member dues and conference revenue, none, fortunately, from taxpayers. An elected ALA counselor sits as a voting member on the NLA Board of Directors. Chapters operate independently, however, the ALA requests them to participate in specific activities or take specific actions. Although separate organizations, the NLA works in partnership with the NE Library Commission, a state agency which does obtain taxpayer appropriations, and is an institutional member of the ALA.

**LEGISLATION.** The NLA takes positions anathema to NE taxpayer interests. It opposes **LB 71: Sanders.** To require all public school districts to make learning and testing materials accessible to parents/taxpayers and permit them to excuse their children from particular activities or lessons. It also opposes **LB 374: Murman.** That every NE parent must have the primary right to direct the education and mental health of their child, including several enumerated rights. One bill clause prohibits the teaching of Critical Race Theory, that one race is inherently superior or inferior, and that Whites bear collective guilt. Several NE public school districts currently teach CRT. To require public schools to disclose instructional materials and activities to parents and allow them to excuse their child from specific lessons or activities. Schools could not require students to complete intrusive questionnaires without parental consent. Parents could file a complaint with the state dept. of education, if their school refuses to remove inappropriate library content, or sue the school district for violating these regulations. Teachers who refuse to teach CRT or matters that contradict their religious beliefs could not face disciplinary action and could sue if sanctioned. The teacher's union, OP\$, and leftist NE Appleseed oppose the bill. The NLA also campaigned against **LB 441: Albrecht**, which would end protections for educators and librarians from prosecution for criminal offenses relating to obscene reading materials given children. These bills still active.

**DIVERSITY GROUP.** The NLA actively solicits members to join its Diversity Interest Group in order to make an impact on equity and help guide its strategic objectives, including Critical Race Theory. NLA meetings discuss bringing additional diversity, equity, accessibility, and inclusion into library collections and catalogs.

**DEFENDING FILTH.** The NLA attacks alleged censorship in our public schools, when angry parents and taxpayers



demand the banning or sequestering in adult sections of sexually explicit books exposed to kids and teens. Masking their endeavors as protecting intellectual freedom, the NLA Advocacy Comm. sponsors weekly meetings. After the Plattsmouth Community School District school board reviewed 51 suspect books and tossed a dozen from the school libraries, the school board next revised a policy to no longer require that libraries follow the American Library Assoc. Library Bill of Rights, which endorses such volumes. The board then passed a measure to remove obscene, excessively vulgar, or harmful to minors

books and established a policy that school libraries can reserve mature content sections that students can access only with written parental permission. The NLA criticized the school board actions. Similarly, the NLA condemned the Papillion School District for removing Something Happened in Our Town, a book authored by leftist activists, the content of which incites anger against and disrespect for law officers. The ALA affiliate American Assoc. of School Librarians awarded the NLA a commendation in 2022. NLA wholeheartedly endorses the ALA book bans stance and cooperates with the ACLU to discuss this issue. NLA conferences honor Banned Books Week, where attendees can discuss social justice and multicultural libraries. In May, 2023, it produced a You Tube video titled Read the Rainbow: Serving the LGBTQIA+Community in Your Library. The average NLA employee salary in July, 2023, was \$83,667.

**TAKE ACTION NOW.** Because the NLA subsists financially on membership dues and contributions, taxpayers cannot lobby elected officials to cut its funding. However, taxpayers can write editorials shaming this organization, ask state senators to pass a resolution criticizing the NLA, lobby NLA directors, and request that it disaffiliate from the ALA and join the World Library Association as an alternative at <a href="https://worldlibraryassociation.org">https://worldlibraryassociation.org</a>.
