An individual may appear before and address the Board on any matter concerning the Board or the university *not on the agenda* by notifying the Corporation Secretary at least 24 hours in advance of the meeting at which the person desires to address the Board. Individual appearances before the Board in this instance limited to 3 minutes. Anyone who wants to present written testimony must deliver the following information to the Corporation Secretary by email, mail, facsimile, or hand delivery, no later than 24 hours in advance of a Board meeting: (a) the name of the person submitting testimony; (b) the address of the person submitting testimony; and (c) the written testimony. The name of the person submitting testimony and topic will be included in the minutes.
