**FINANCIAL MISMANAGEMENT.** On Nov. 1, 2023, the LC credit card balance stood at -\$4,264.99; on Nov. 30, the negative balance reached -\$5,135.83. By Dec. 31, 2023, the negative balance had dipped to -\$10,943.97. \$145 for Lyft rides though the LC has vans. \$94.63 splurged at Mexican restaurants in addition to meals at restaurants listed above. \$605 spent on LC advertising Sept.-Nov. 2023. Although the LC mission is to educate kids, \$1,585,324 spent on Parent University. \$141,500 spent on Child Care Director training. \$162,000 spent on community relations and \$33,000 earmarked for lobbying. Dollars for game night with parents. 298 families referred to welfare services by staff. The LC pays for outside professional assistance, though it should have permanent staff to handle these responsibilities.

ACADEMIC DISAPPOINTMENT. The 2022-2023 LC Annual Evaluation portrayed poor academic results. Only 12% of LC students pegged above average for student initiative, only 18% of students above average for self-control. For vocabulary scores, 15% above average, 51% below average. Only 55% evidenced mastery of letters; only 45% demonstrated mastery of numbers. Only 13%-15% of students above average in language skills. All students fell below average in math concepts and application and applied problems. In math, only 27% of pupils above average, 24% below average. On the NE State Assessment Math Test, only 3% reached advanced math status, only 10% on track. In reading, only 24% above average, 32% below average. Only 58% of LC kids attending OPS missed fewer than 10 days of school.

**TAKE ACTION NOW.** The LC administration and board continue to waste taxpayer \$\$ on non-basic services and act more like a welfare agency system than an educational one, recklessly spending tax \$\$. The LC continues to provide no evidence of remedial or regular academic effort that would prepare its enrolled children to advance academically in regular public school classrooms. Therefore, the only solution is to eliminate this bureaucracy through state legislative effort, because local education and other officials refuse to expose the LC worthlessness.
